Disruptions in care seeking and access to quality health care for children at primary health facilities and in communities increase children's risk of severe illness and death. How do countries ensure safe continuation of child health services during COVID-19? How were case management algorithms and patient flow adapted and re-organized, infection control measures implemented, PPE and uninterrupted supplies ensured? How were children screened for COVID-19 while continuing routine case management for common childhood illnesses? Did approaches differ based on local transmission of COVID-19?

During this webinar, we will hear practical examples and experiences on how two countries, Uganda and Senegal, adapted and implemented changes in integrated community case management (iCCM) and Integrated Management of newborn and childhood illness (IMNCI) to provide continued quality care for young children.

Despite one in every three facility births occurring in private facilities in India, efforts to improve the quality of maternal health around the time of birth have largely focused on public health facilities in the country.

Manyata, a certification programme with both quality improvement and assurance components, is designed to strengthen quality of maternal health services in private facilities. Since its launch in 2013, Manyata has developed a viable business model for quality assurance and laid the groundwork for sustainable quality improvement efforts in the private maternal health care sector in India. The programme, now in its third phase, is implemented in Uttar Pradesh, Jharkhand and Maharashtra by Jhpiego and in Rajasthan, Karnataka and Tamil Nadu by other partners.

This webinar will share Manyata's approach to initiate a private sector endeavour and develop a successful public-private partnership for quality of care, the value it provided for private providers to invest in quality of care, and its plan to expand its activities to other states. A representative of the Government of Maharashtra will also explain how the state government plays a critical role to ensure private facilities adopt standards of care under the LaQshya-Manyata initiative.

New podcast episode: COVID-19 lockdown & pregnancy complications: Lessons from Nepal on providing quality intrapartum care in extraordinary times

A recent study conducted in Nepal assessed the indirect impact of the COVID-19 lockdown on the quality of intrapartum care that women received in health facilities. The [study](#), published in The Lancet, looks at the implications of a reduced access to care, but also at the gaps in the quality of the care provided.

Dr. Ashish K.C, who led the study, is a perinatal epidemiologist and a researcher specializing in quality of care, based in the Department of Women's and Children's Health, University of Uppsala, Sweden. He tells us about the study's findings, their implications during the COVID-19 lockdown, and how health workers have developed solutions to provide quality intrapartum care even under extraordinary circumstances.

Shaped by country engagement and priorities, AlignMNH will serve to amplify existing efforts; more rapidly disseminate emerging evidence and science; fuel country-led coordinated advocacy and action; identify, translate and curate learning that is actionable and accessible to guide program implementation; and promote mutual accountability.

The AlignMNH platform will promote opportunities to work across countries to share learning, identify challenges, generate solutions and celebrate progress.

The Network for Improving Quality of Care for Maternal, Newborn and Child Health (Quality of Care Network) works to ensure that every pregnant woman and newborn receives good quality care throughout pregnancy, childbirth and the postnatal period, with the ambitious goal to halve maternal and newborn deaths and stillbirths in health facilities within five years in the participating countries.

The Quality of Care Network is led by countries that are already taking leadership to improve quality of care in health services: Bangladesh, Côte d'Ivoire, Ethiopia, Ghana, India, Kenya, Malawi, Nigeria, Sierra Leone, Tanzania, and Uganda. More countries are expected to join the Network. It is backed by the World Health Organization, UNICEF and UNFPA, and supported by a growing partnership of development organisations, NGOs, professional associations and universities.

It is underpinned by the values of quality, equity and dignity and contributes to achieving the targets of the *Every Woman Every Child Global Strategy for Women's, Children's and Adolescents' Health*.
